Now the timestamp of all events is correct, even in this case.
- Item 127182: If a job had been cancelled, the building time showed zero seconds in the report. The overall time was then also based on a building time of zero seconds. Now the building time on the report is correct, even if the job had been cancelled.
- Item 129398: The number of interruptions for the Part Report was based on all the interruptions that occurred during the job. Now for the Part Report, the number is only based on the interruptions that occurred during the building of the selected parts.
